<b>U.S. AIR FORCE CONFINEMENT REQUIREMENTS</b>		
<b>THE PRISONER'S COMMAND IS REQUIRED TO MAKE UP ANY CLOTHING SHORTAGES WITHIN 72 HOURS OF INITIAL CONFINEMENT. THE UNIT MUST PROVIDE A POC NAME AND PHONE NUMBER.</b>

<b>1</b>	Complete Dress Uniform for Court Appearances <b>Note: Ensure the Appropriate Rank Accompanies Service Dress Uniform</b>	
<b>2 pr</b>	Boots w/Laces	
<b>5</b>	Brassieres/Sport Bras (females only) (white or beige, no wire)	
<b>1</b>	Patrol Cap with Appropriate Cloth Grade/Rank Insignia	
<b>1</b>	Service Appropriate Utility/Field Jacket	
<b>4</b>	ABU Blouses with Appropriate Cloth Rank Insignia (no metal/plastic accoutrements)	
<b>4 pr</b>	ABU Trousers	
<b>1 pr</b>	Gym shoes	
<b>8 pr</b>	Black Socks (No logos or ankle socks)	
<b>8 pr</b>	White Socks (No logos or ankle socks)	
<b>6</b>	Undershirts (cotton only/no logos or unit design)	
<b>6</b>	Underwear/Panties (white only)	
<b>4 pr</b>	PTU/IPTU Running Shorts** (Service Authorized)	
<b>4</b>	PTU/IPTU Short-sleeved Shirts** (Service Authorized)	
<b>1</b>	PTU/IPTU Sweatshirt or Jacket** (Service Authorized) (Optional)*	
<b>1 pr</b>	PTU/IPTU Running Pants** (Service Authorized)	
<b>4</b>	IPTU Long-Sleeved (Optional)	
<b>1 pr</b>	Shower Shoes (Black only/No logos)	
<b>1</b>	Soft-Cover Bible (Optional)	
* Highly recommended because of temperature extremes **Do not mix the current PTU running suit jacket and pants with the IPTU jacket and pants. All other combinations authorized.		
All unauthorized items will be turned back over to the escort team. Examples of unauthorized items include: civilian clothing, high dollar value personal items, cell phones, vehicle keys, barracks keys, mail box keys, TA-50 equipment
